Please refer your RTI application dated 12/3/2018 addressed to CPIO, Ministry of Home Affairs, which was transferred to RTI Cell, Ministry of External Affairs and received by this Division with registration Nos - MOEAF/R/2018/80109 and MOEAF/R/2018/80121 on 12/3/2018 and 20/3/2018 respectively.

2. The information pertaining to the undersigned CPIO with respect to your queries on China is as follows:

There is no commonly delineated Line of Actual Control (LAC) in the border areas between India and China. From time to time, on account of differences in the perception of the LAC, situations have arisen on the ground that could have been avoided if we had a common perception of the LAC.

Government regularly takes up any transgression along the LAC with the Chinese side through established mechanisms including border personnel meetings, flag meetings, meetings of Working Mechanism for Consultation & Coordination on India-China Border Affairs, as well as through diplomatic channels.

The Government consistently maintains that peace and tranquility in the India-China border areas is an important pre-requisite for the smooth development of bilateral relations.

3. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi - 110011, within a month from the date of receipt of this letter.
