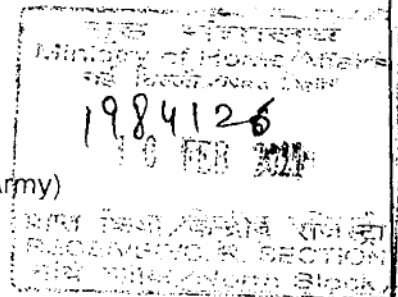

4. Please confirm whether Chinese troops entered inside Indian Territories across any State and Union Territory of India on or before 26/Jan/2021. Kindly provide on record (Govt of India) Chinese Intrusion details as on 26/Jan/2021.
5. What competent offensive and defensive steps Department of Military Affairs (DMA), GoI (Defense Ministry in particularly) have taken to STOP such unlawful incursion, aggression in Indian Territories on or before 26/01/2021 (Republic Day of India) to ensure Territorial Integrity and Sovereignty of India. Please provide truthful certified details.
