Please refer to your RTI application dated 13/05/2015 received online by RTI Cell, Ministry of External Affairs (MEA) New Delhi.


2. The response to your query is as follows:

Government is aware that China is involved in the construction of or assistance to infrastructure projects in our neighborhood including in hydroelectric & nuclear projects, highways, motorways, export processing zones and economic corridors in Pakistan. Government has seen reports with regard to China involved in infrastructural activities in Pakistan Occupied Kashmir (POK). Government has conveyed its concerns to China about their activities in Pakistan Occupied Kashmir, and asked them to cease such activities.

Government keeps a constant watch on all developments having a bearing on India's security and takes all necessary measures to safeguard it.
