Please refer to your RTI application dated 27/06/2015 received on 28/07/2015 seeking information under the RTI Act, 2005.

It also appears that some of the information asked for is in respect of Missions and Posts abroad which are separate Public Authorities. You are advised to file separate RTI applications with concerned Missions and Posts. As the required information would be available with them. Under Section 2(h) of the RTI Act, Indian Missions/Posts abroad are independent and distinct Public Authorities. (In terms of DoPT's O.M no. 10/02/2008-IR dated 24/09/2010), if a person makes an application for information which is scattered with more than one public authority, the applicant should be advised to file separate applications to the public authorities concerned.
