

2. Part A regarding number of employees retired, died in Service as on 01.04.2015 concerns the undersigned. It is, however, pointed out that the required information does not exist at a single source in a compiled form as defined in Section 2(f) of the RTI Act, 2005. The information is scattered across different files pertaining to different years and its compilation and collation would result in disproportionate diversion of resources. The information, therefore, cannot be provided as per Section 7(9) of RTI Act, 2005.
