Sir/Madam,

The complaint dated 13/08/2013 received from OMPRAKASH PODDAR, ADVOCATE & RTI ACTIVIST in respect of 7 ARMY PERSONNEL INDIAN ARMY, was placed before the Commission on 19/12/2014. Upon perusing the complaint, the Commission directed as follows.

*These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 07.08.2014 wherein the petitioner was asked to offer his comments, if any, on the report of Ministry of Defence within six weeks.*

*The petitioner vide his communication dated 11.09.2014 has stated that the report of Director (G), Ministry of Defence is incomplete and misleading. It has been stated the report with regard to the incident of dated 08.01.2013 is contrary to the press statement of army Chief. The same contradiction is there on the incident dated 06.08.2013 when five army personnel were killed while asleep by the Pakistani army personnel. It has been stated that the Govt. and the senior army authorities are not serious in safe guarding human rights of the army personnel on Pakistan Border.*

*The Commission has considered the matter. The observations made by the petitioner on the incidents at international border are general in nature. As per report, the Govt. has taken appropriate action and has raised the concern at bilateral level. In the light of facts and circumstances of this case, let a copy of the response dated 11.09.2014 be transmitted to the Secretaries, Ministry of Home Affairs, Ministry of Defence and Ministry of External Affairs for action as deemed appropriate. With these directions, the report is taken on record and the case is closed.*

2. Accordingly, I am forwarding a copy of the complaint for necessary action as per the directions of the Commission.
