Background


CPIO vide letter no. Yer/Admn/551/2/2011 dated November 04, 2015 furnished the hard of copy of the information 4 (1) (b) in English only as available in Embassy's website and also the information regarding foreign tours by the officers in Embassy of India, Yerevan in the present government (i.e. since May, 2014).

2. The applicant vide his application dated 22/11/2015 has preferred an Appeal under the RTI Act for not furnishing the complete information sought.

Decision on Appeal

3. I called the concerned file in which CPIO had taken his decision and also perused the reply of CPIO. The information regarding 4 (1) (b) of RTI Act is available in Embassy's website in English language only and hard copy of the same has already been forwarded to the applicant. I have also seen the information regarding foreign tours by the officers in Embassy of India, Yerevan in the present government (i.e. since May, 2014) as provided by CPIO and found it correct.

4. In view of the above, the Appeal is disposed off.
